



GOMO Broadband September Promotion TERMS & CONDITIONS

1. The GOMO Broadband September Promotion (the “**Promotion**”) is offered by SingNet Pte. Ltd. (“**GOMO**”) and will run from 3 September 2026 to 17 September 2026 (both dates inclusive) (the “**Promotional Period**”), or such other period as determined by GOMO.
2. The Promotion will be made available through selected promotional channels and/or locations during the respective periods specified in Clause 9 below (each an “**Applicable Promotional Period**”).
3. By participating in the Promotion, participants agree to be bound by these Terms and Conditions.

PROMOTIONAL MECHANICS

4. The Promotion is open to individuals signing up for an eligible GOMO Broadband plan during the relevant Applicable Promotional Period.
5. To qualify for the Promotion, customers must:
 - a. successfully sign up for an eligible GOMO Broadband plan through the applicable promotional channel or location during the corresponding Applicable Promotional Period;
 - b. apply the corresponding promo code specified in Clause 9 at the point of sign-up;
 - c. successfully complete the activation and installation of their GOMO Broadband service.
6. Subject to these Terms and Conditions, each eligible customer will receive one (1) \$30 FairPrice e-Voucher for each qualifying GOMO Broadband sign-up.
7. The Promotion is limited to one (1) \$30 FairPrice e-Voucher per qualifying GOMO Broadband sign-up. Promo codes cannot be used in conjunction with any other promo code, unless otherwise stated by GOMO.
8. The FairPrice e-Voucher will be sent to the eligible customer’s registered email address within two (2) months after successful service activation and installation, subject to the broadband service remaining active and in good standing for at least thirty (30) days after activation and the customer satisfying all other eligibility and validation requirements set out in these Terms and Conditions.

FRAUD & ABUSE PREVENTION

10. The broadband service must remain active and in good standing for a minimum of thirty (30) days after activation.
11. Any cancellation, suspension or termination within the validation period may result in disqualification.
12. Sign-ups generated through fraudulent activity, manipulation, abuse of the Promotion mechanics, identity misrepresentation, or any conduct that compromises the integrity of the Promotion may be disqualified.
13. GOMO reserves the right to audit, investigate and verify all sign-ups before voucher fulfilment.
14. If GOMO determines that a sign-up is invalid, fraudulent or otherwise in breach of these Terms and Conditions, GOMO reserves the right to disqualify the customer and withhold or withdraw the applicable e-Voucher.

To the fullest extent permitted by law, Singtel, GOMO, their affiliates, agencies and partners shall not be liable for any loss, damage, injury, expense or claim arising from or in connection with participation in the Promotion or the acceptance, use or redemption of any prize, except where such liability cannot be excluded under applicable law.
