

Samsung Galaxy Note9 Promotions Terms & Conditions

One-time SIM Card and registration fee of \$48.15 applies for the MobileShare line. Early termination charges apply. The MobileShare line must be tied to the same NRIC and billing account as the Combo Plan with the Note9. Limited to 1 free Tab A 8.0 per new MobileShare line signed up, while stocks last. Promotion is applicable to eligible Residential/CIS/Biz Sales Combo Plan customers. Promotion is not stackable and cannot be combined with other promotions. - 3) Purchase of the device is subject to a 24-month mobile contract.
 - i. For mobile lines eligible for re-contract between the 6th to 11th month of the contract, an additional \$500 will be charged.
 - ii. For mobile lines eligible for re-contract between the 12th to 17th month of the contract, an additional \$350 will be charged.
 - iii. For mobile lines eligible for re-contract between the 18th to 20th month of the contract, an additional \$200 will be charged.
- 4) With effect from 7 April 2017, the minimum age for subscribing to a postpaid mobile line is 18 years old. Customers under the age of 18 years old are required to transfer ownership to a sponsor before re-contracting the line.
- 5) Any outstanding payments due to Singtel or your current mobile service provider should be cleared in order to be eligible to participate in Reservation and Purchase of the handset.
- 6) For foreigners holding a Work Permit, Social, Student or Dependent Pass, the pass should be valid for at least 12 months from the re-contract date. For S Pass holders, the S Pass should be

valid for at least 6 months from the re-contract date. For Employment Pass holders, the Employment pass should be valid for at least 6 months from the re-contract date.

- 7) A deposit may be required for each new line signed up or re-contracted.
- 8) Please bring along your old device with any other accessories that form the basic phone package if you wish to trade-in your old device.
