(with effect from 26 November 2019) The customer shall have the option to subscribe to Meg@POP services in Table A or Table B under the Customised Scheme.

¹ The data from all SIM cards subscribed will be pooled dynamically into a single shared data pool. Excess data will be calculated monthly based on the aggregated excess data consumed by all subscribed SIM cards in excess of the shared data pool for the relevant month. Excess data charges will be charged on a per billing account basis instead of per SIM card basis. There is no cap for excess data charges.

The customised tariffs will be applicable to all new and renewed Meg@POP circuits subscribed under the Customised Scheme.

Terms and Conditions

1. The contract term of the Customised Scheme is three (3) years.
2. The contract term of the services subscribed under the Customised Scheme is three (3) years.
3. Circuits subscribed under the Customised Scheme will continue at the customised prices after expiry of the circuit contract term
4. The services offered under the Customised Scheme are subject to resource availability.
5. The customer shall not resell the services subscribed under the Customised Scheme “as is” or as a standalone Meg@POP product.
6. **(with effect from 26 November 2019)** In the event that the customer wishes to migrate its existing services in Table A to Table B, any applicable premature termination charge for these services will be waived.
7. If the customer terminates the service(s) subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for a premature termination charge of 100% of the remaining contract term.
8. No other discounts including, but not limited to, term and volume discounts, shall be applicable to the services subscribed under the Customised Scheme.
9. All other standard prices, terms and conditions of the Singtel Meg@POP service shall remain applicable.

Eligibility:

The Customised Scheme will be offered to all similarly situated customers who satisfy the following criteria:

- a) **(with effect from 26 November 2019)** must have or is willing to commit to the minimum number of circuits prescribed in Table A or B; and
- b) accepts the terms and conditions of the Customised Scheme in its entirety.
