The customised tariffs will be applicable to all new and renewed Dark Fibre circuits subscribed under the Customised Scheme.

**Terms and Conditions:**

1. The contract term for the Customised Scheme is one (1) year.
2. The contract term for the services subscribed under the Customised Scheme is one (1) year.
3. Relocation of services subscribed under the Customised Scheme will be charged at an OTC of \$1,000 per pair per site. For avoidance of doubt, relocation of both ends of a service (i.e. 2 sites) will be charged at \$2,000 per pair.
4. The service(s) subscribed under the Customised Scheme are subject to resource availability.
5. Both ends of the Dark Fibre Service subscribed under the Customised Scheme must connect to a data centre.
6. The customer shall not resell the service 'as is' or as a full or sub-bandwidth standalone Dark Fibre product.
7. No other discounts including, but not limited to, term and volume discounts, are applicable to the services subscribed under the Customised Scheme.

8. Circuits subscribed under the Customised Scheme will continue at the customised prices after expiry of the circuit contract term.
9. All other standard prices, terms and conditions of the commercial Singtel Dark Fibre service shall remain applicable.

**Suspension and Termination Provisions:**

If the customer terminates any of the services subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for a premature termination charge (**PTC**) of 100% of the remaining contract term.

**Eligibility:**

(with effect from 1 December 2018)

- c) accepts the terms and conditions of the Customised Scheme in its entirety.
