Any additional relocation charge waiver is subject to the relocation request being submitted together with a contract renewal or upgrade under the Customised Scheme. For avoidance of doubt, for any relocation request beyond 5 and not submitted together with a contract renewal or upgrade under the Customised Scheme, the prevailing relocation charge will apply.

- 1.
