The customised tariffs will be applicable to all new and renewed Dark Fibre circuits subscribed under the Customised Scheme.

**Terms and Conditions:**

1. The contract term for the Customised Scheme is three (3) years.
2. The contract term for the services subscribed under the Customised Scheme is three (3) years.
3. In the event that a customer with 4 existing pairs of dark fibre service under the Customised Scheme subscribes for one or more additional pair(s), all pairs of dark fibre will be charged at an MRC of \$2,400 per pair on the condition that the contract term of the existing dark fibre services will be renewed for another three (3) years. For avoidance of doubt, the premature termination charge (PTC) for the existing 4 pairs of dark fibre will be waived if the existing dark fibre services are renewed for another three (3) years.
4. No other discounts, including but not limited to, term and volume discounts, shall apply to the Customised Scheme.
5. The customer shall not resell the service 'as is' or as a full or sub-bandwidth standalone Dark Fibre product.
6. Circuits subscribed under the Customised Scheme will continue at the customised prices after expiry of the circuit contract term

7. The service(s) subscribed under the Customised Scheme are subject to resource availability.
8. All other standard prices, terms and conditions of the Singtel Dark Fibre service shall remain applicable.

**Suspension and Termination Provisions:**

If the customer terminates the service(s) subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for a PTC of 100% of the remaining contract term, except where the condition under clause 3 in the Key Terms and Conditions is fulfilled.
