Terms and Conditions:

1. The contract term of the Customised Scheme is two (2) years.
2. The contract term for the services subscribed under the Customised Scheme is one (1) or two (2) years, with an option to extend on a monthly basis for a period of up to six (6) months.
3. In the event that the customer does not meet the minimum quantity required, all circuits subscribed under the Customised Scheme shall revert to prevailing list prices.
4. There shall be no auto-renewal of the Customised Scheme.
5. The services offered under the Customised Scheme are subject to resource availability.
6. The customer shall not resell the services subscribed under the Customised Scheme.
7. **(with effect from 31 January 2020)** Circuits subscribed under the Customised Scheme will continue at customised prices after the expiry of the circuit contract term.
8. No other discounts including, but not limited to, term and volume discounts shall apply.
9. All other standard prices, terms and conditions of the Singtel DigiNet, Gigawave, MetroEthernet and Meg@POP services shall remain applicable.

Suspension and Termination Provisions:

If the customer terminates the service(s) subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for a premature termination charge (PTC) of 100% of the remaining contract term.

Eligibility:
