3. **(With effect from 27 August 2021)** The customer shall subscribe to the minimum quantity of circuits specified under the Customised Scheme.
4. **(With effect from 27 August 2021)** Circuits subscribed under the Customised Scheme will continue at customised prices after the expiry of the circuit contract term.
5. The service(s) offered under the Customised Scheme are subject to resource availability.
6. The customer shall not resell the services subscribed under the Customised Scheme.
7. No other discounts including, but not limited to, term and volume discounts, are applicable to the services subscribed to the Customised Scheme.
8. All other prices, terms and conditions of the Singtel Gigawave, Meg@pop and MetroEthernet services shall remain applicable.

#### **Suspension and Termination Provisions:**

If the customer terminates any of the service(s) subscribed under the Customised Scheme during the contract term of the service(s), prevailing premature termination charges will apply.
