1. The contract term for the Customised Scheme is three (3) years.
2. **(with effect from 10 December 2021)** The contract term for the services subscribed under the Customised Scheme is one (1), two (2) or three (3) years as per the pricing tables.
3. **(with effect from 10 December 2021)** Should the customer subscribe to Table 2 services, the customer shall subscribe to at least two (2) Gigawave circuits from Table 2 in each order.
4. The service(s) subscribed under the Customised Scheme are subject to resource availability.
5. The customer shall not resell the services subscribed under the Customised Scheme “as is” or as a standalone Gigawave product.
6. Circuits subscribed under the Customised Scheme will continue at the customised prices after the expiry of the circuit contract term.
7. No other discounts including, but not limited to, term and volume discounts, are applicable to the services subscribed under the Customised Scheme.
8. All other standard prices, terms and conditions of the Singtel Gigawave service shall remain applicable.

Suspension and Termination Provisions:

If the customer terminates the services subscribed under the Customised Scheme during the contract term of the services, the customer shall be liable for a premature termination charge (PTC) of 100% of the remaining contract term.
