1. In the event of an EVC reconfiguration, the customer shall be charged the prevailing reconfiguration charge.
2. The customised tariffs include any combination of Class of Service (**CoS**) that the customer wishes to apply to the circuit. For the avoidance of doubt, the sum of CoS bandwidths cannot exceed the bandwidth of the Meg@POP circuit.
3. The customised tariffs will be applicable to all new, renewed and upgraded Meg@POP and MetroEthernet circuits subscribed under the Customised Scheme.

Terms and Conditions

1. The contract term for the Customised Scheme is four (4) years.
2. The minimum contract term for the services subscribed under the Customised Scheme is one (1) year.
3. The customer shall not resell the services subscribed under the Customised Scheme.
4. The service(s) subscribed under the Customised Scheme are subject to resource availability.
5. No other discounts including, but not limited to, term and volume discounts, are applicable to the services subscribed under the Customised Scheme.
6. Circuits subscribed under the Customised Scheme will continue at the customised prices after expiry of the circuit contract term.
7. All other standard prices, terms and conditions of the Singtel Meg@POP and MetroEthernet services shall remain applicable.

Suspension and Termination Provisions:

1. Subject to the above, in the event the customer terminates any service(s) subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for the prevailing PTC.
