A Gigabit Ethernet interface for Meg@POP IPVPN EthernetLink Outdoor and Meg@POP IPVPN EthernetLink Outdoor with Path Diversity services will be offered in addition to the standard copper interface at the same customised prices.

Meg@POP IPVPN EthernetLink with Path Diversity circuits must be paired with a Meg@POP IPVPN EthernetLink circuit of the same bandwidth. For the avoidance of doubt, only one (1) Meg@POP IPVPN EthernetLink with Path Diversity circuit may be paired to each Meg@POP IPVPN EthernetLink circuit.

If path diversity cannot be provided, the customer shall be eligible to subscribe to a Meg@POP IPVPN EthernetLink with Exchange Diversity circuit at the same customised prices.

Terms and Conditions:

1. The contract term for the Customised Scheme is three (3) years.
2. The contract term for the services subscribed under the Customised Scheme is as stated in the pricing tables.
3. The service(s) subscribed under the Customised Scheme are subject to resource availability.
4. The customer shall not resell the services subscribed under the Customised Scheme.
5. Circuits subscribed under the Customised Scheme will continue at the customised prices after the expiry of the circuit contract term.
6. No other discounts including, but not limited to, term and volume discounts, are applicable to the services subscribed under the Customised Scheme.
