9. For Meg@POP Ethernetlink services subscribed under the Customised Scheme, the customer is eligible for Relocation OTC waiver.
10. All other standard prices, terms and conditions of the Singtel Teams UC Connector and Meg@POP service shall remain applicable.

Suspension and Termination Provisions:

The customer is eligible for waiver of Premature Termination Charge (**PTC**) for existing Meg@POP circuit(s) when the circuit(s) is renewed under the Customised Scheme.

The customer is eligible for waiver of PTC for existing SIP Trunking service(s) subject to service migration to Teams UC Direct Connect service under the Customised Scheme.

In the event of site closure, the customer is eligible for waiver of PTC for one (1) existing Meg@POP circuit only.

If the customer terminates the service(s) subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for a PTC of 100% of the remaining contract term.
