Key Terms and Conditions:

1. (With effect from 14 August 2024) The contract term of the Customised Scheme is a minimum of 60 months.
2. (With effect from 14 August 2024) The contract term of the Dark Fibre service subscribed under the Customised Scheme is a minimum of 60 months.
3. (With effect from 14 August 2024) *deleted*
4. The service(s) provided under the Customised Scheme must be used for the Singapore Grand Prix race.
5. (With effect from 14 August 2024) *deleted*
6. The customer shall not resell the services subscribed under the Customised Scheme “as is” or as a standalone service but may use the service as part of its own network to offer its own service(s).
7. The service(s) under the Customised Scheme are subject to resource availability. In the event where resources are not available, remote location charges shall apply.
8. (With effect from 14 August 2024) The Dark Fibre cable may have a maximum of 192 cores of fibre.

9. The total length of the Dark Fibre cable can be up to a maximum of five (5) kilometres.
10. No other discounts including, but not limited to, term and volume discounts, are applicable to the services subscribed to the Customised Scheme.
11. **(With effect from 14 August 2024)** *deleted*
12. The charges for the service(s) under the Customised Scheme shall remain valid and not subject to review during the contract term.
13. **(With effect from 14 August 2024)** All other standard terms and conditions of the commercial Singtel Dark Fibre service shall remain applicable.

Suspension and Termination Provisions:

If the customer terminates the services subscribed under the Customised Scheme before the end of the contract term, the customer will be liable for Premature Termination Charge (**PTC**) of 100% of the recurring charge for the remaining contract term.

Notwithstanding the above, if the customer terminates the service(s) under the Customised Scheme during the contract term of the service, no monies paid shall be refunded.
