1. **(With effect from 14 June 2023)** The contract term of the Customised Scheme is two (2) years with the option to extend for one (1) year.
2. The contract term of the services subscribed under the Customised Scheme is as indicated in the pricing table.
3. **(With effect from 14 June 2023)** The customer shall subscribe to the minimum quantities under the Customised Scheme. In addition, the customer shall subscribe to the minimum quantity of Dark Fibre services as specified in Table B under the Customised Scheme in a single order.
4. In the event of relocation, the customer shall pay a relocation fee of the OTC for each relocated circuit.
5. The customer shall not resell the service “as is” or as a full or sub-bandwidth standalone Dark Fibre product.
6. Circuits subscribed under the Customised Scheme will continue at customised prices after the expiry of the circuit contract term.
7. The service(s) offered under the Customised Scheme are subject to resource availability.
8. No other discounts, including but not limited to, term and volume discounts, shall be applicable to the services subscribed under the Customised Scheme.
9. All other standard prices, terms and conditions of the commercial Singtel Dark Fibre service shall remain applicable.

Suspension and Termination Provisions:

In the event the customer terminates the service(s) subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for a premature termination charge of 100% of the remaining contract term.
