Key Terms and Conditions:

1. The contract term of the Customised Scheme is three (3) years.
2. **(With effect from 29 April 2022)** The contract term of the services subscribed under the Customised Scheme is as per the pricing tables.
3. **(With effect from 29 April 2022)** The customer shall subscribe to the minimum quantity as described in Table A.
4. **(With effect from 29 April 2022)** Service(s) subscribed by the customer and its subsidiaries can be combined to meet the minimum quantity requirements.
5. The services subscribed under the Customised Scheme are subject to resource availability.
6. Both ends of the Dark Fibre service subscribed under the Customised Scheme must be connected to a Data Centre.
7. **(With effect from 16 July 2021)** The customer shall not resell the service 'as is' or as a full or sub-bandwidth standalone Dark Fibre or Gigawave product.
8. Circuits subscribed under the Customised Scheme will continue at customised prices after the expiry of the circuit contract term.
9. No other discounts including, but not limited to, term and volume discounts, are applicable to the services subscribed under the Customised Scheme.
10. **(With effect from 16 July 2021)** All other standard prices, terms and conditions of the commercial Singtel Dark Fibre and Gigawave service shall remain applicable.

Suspension and Termination Provisions:

If the customer terminates the service(s) subscribed under the Customised Scheme before the end of the contract term of the service(s), the customer shall be liable for a premature termination charge (PTC) of 100% of the remaining contract term. If the Dark Fibre service is terminated after fulfilling at least one (1) year of the contract term, PTC shall be waived.
