6. The customer is entitled to a waiver of premature termination charges (**PTC**) for any existing Meg@POP IPVPN EthernetLink circuits, provided that:
 - a. The circuit is renewed as a 2 Gbps Meg@POP IPVPN EthernetLink or 2 Gbps Meg@POP IPVPN EthernetLink with Exchange Diversity circuit under this Customised Scheme; and
 - b. The total contract value of the service contract term of the renewed circuit is greater than the remaining total contract value of the existing service contract term.

For the avoidance of doubt, the original circuit can be subscribed under any customised scheme, promotion or list price.

7. No other discounts including, but not limited to, term and volume discounts, shall be applicable to the services subscribed under the Customised Scheme.
8. Circuits subscribed under the Customised Scheme will continue at customised prices after the expiry of the circuit contract term.
