Terms and Conditions:

1. The contract term of the Customised Scheme is five (5) years and for the avoidance of doubt, will not be perpetually available.
2. The contract term of the services subscribed under the Customised Scheme is as specified in the pricing table.
3. The customer shall subscribe to the minimum quantities as stated in the pricing table above.
4. If the customer fails to subscribe to the minimum quantities under the Customised Scheme, the customer shall pay a shortfall amount, calculated as follows:

$$\text{Shortfall amount} = \text{Shortfall quantity of circuits} * \text{MRC} * \text{circuit contract term}$$

5. Services subscribed by the customer and its related companies can be combined to meet the minimum volume required.
6. The services subscribed under the Customised Scheme are subject to resource availability.
7. The customer shall not resell the services subscribed under the Customised Scheme.
8. Circuits subscribed under the Customised Scheme will continue at the customised prices after the expiry of the circuit contract term.
9. No other discounts including, but not limited to, term and volume discounts, are applicable to the services subscribed under the Customised Scheme.
10. All other standard prices, terms and conditions of the Singtel Meg@POP service shall remain applicable.

Suspension and Termination Provisions:

If the customer terminates the service(s) subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for a premature termination charge (PTC) of 100% of the MRC for remaining contract term.
