OTC shall be waived for circuits that are for renewal, upgraded or migrated under the Customised Scheme. For the avoidance of doubt, OTC applies to new circuits.

A rebate of \$120 will be given to the MRC for new subscriptions for MetroEthernet PTMP and PTP circuits. This is only applicable for Bandwidths from 10 Mbps to 100 Mbps. Circuits subscribed under this rebate tariff will carry on with this rebate scheme upon renewal of the circuits.

The customer shall be eligible for a waiver of Multiple VLAN charges for MetroEthernet circuits subscribed under the Customised Scheme.

The customised tariffs will be applicable to all new, renewed, upgraded and/or migrated MetroEthernet, Gigawave and Dark Fibre circuits subscribed under the Customised Scheme.

Key Terms and Conditions:

1. **(With effect from 1 February 2024)** The contract term of the Customised Scheme is three (3) years, with an option to extend for six (6) months.
2. **(With effect from 1 February 2024)** The contract term of the services subscribed under the Customised Scheme is as per the pricing tables.
3. The customer is eligible for additional free head-end circuit(s), subjected to the following conditions:
 - a) all of the customer's existing head-ends at a specific location (in totality) is at least 50% utilised. Upon which, the customer will be eligible for one (1) free head end;

- b) the free head-end will be deployed at the same location at the existing head-end;
and
- c) Singtel will determine the bandwidth of the free head-end to provision.
- 4. Circuits subscribed under the Customised Scheme will continue at the customised prices after expiry of the circuit contract term.
- 5. The customer is not allowed to resell the service(s) subscribed under the Customised Scheme 'as is' or as a standalone MetroEthernet, Gigawave and Dark Fibre service but may use the service as part of its own network to offer its own service(s).
- 6. The customer shall be responsible for obtaining all authorisation(s) necessary for Singtel to access the customer's Point-of-Presence (**POP**).
- 7. The tariff excludes co-location and any service level agreement.
- 8. The services offered under the Customised Scheme are subject to resource availability.
- 9. All other standard prices, terms and conditions of the Singtel MetroEthernet, Gigawave and Dark Fibre service shall remain applicable.

Suspension and Termination Provisions:

If the customer terminates the service(s) subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for a premature termination charge (**PTC**) of 100% of the remaining contract term.

Eligibility:

(With effect from 1 February 2024) The Customised Scheme is available to all similarly situated customers who satisfy the following criteria:

- a) is a duly licensed Facility Based Operator (**FBO**) or Services Based Operator (**SBO**);
- b) **(With effect from 1 February 2024)** currently have 70 circuits of MetroEthernet service; 2 circuits of Gigawave service and 3 Dark Fibre pairs; and
- c) accepts the terms and conditions of the Customised Scheme in its entirety.
