**Key Terms and Conditions:**

1. The contract term of the Customised Scheme is three (3) years.
2. The contract term of the services subscribed under the Customised Scheme is three (3) years.
3. The customer shall subscribe to the minimum quantity as stated in the pricing table above.
4. The services subscribed under the Customised Scheme are subject to resource availability.

5. Upon site survey confirmation, in-building Meg@POP EthernetLink with Path Diversity circuits shall only be provided on different paths if there are two (2) separate lead-ins and two (2) separate risers that lead to the same location. In the event where Meg@POP IPVPN EthernetLink with Path Diversity circuit is not available, Singtel will provide the customer with a Meg@POP IPVPN EthernetLink with Exchange Diversity service at the same price.
6. The customer shall not resell the services subscribed under the Customised Scheme.
7. Services subscribed under the Customised Scheme will continue at the customised prices after the expiry of the service contract term.
8. No other discounts including, but not limited to, term and volume discounts, are applicable to the services subscribed under the Customised Scheme.
9. All other standard prices, terms and conditions of the Singtel Meg@POP service shall remain applicable.

**Suspension and Termination Provisions:**

If the customer terminates the service(s) subscribed under the Customised Scheme before end of the contract term of the service(s), the customer will be liable for a premature termination charge (**PTC**) of 100% of the remaining contract term.

Notwithstanding the above, the customer may enjoy a PTC waiver for up to fifteen (15) existing Meg@POP eLite circuits (subscribed under this Customised Scheme or other customised scheme) during the contract term of the service(s), provided that the terminated circuits have fulfilled at least twelve (12) months of the contract term of the service(s).
