1. The contract term of the Customised Scheme is two (2) years.
2. **(With effect from 16 December 2022)** The contract term of the services subscribed under the Customised Scheme is as specified in the pricing tables.
3. **(With effect from 16 December 2022)** Both ends of the services subscribed under Table B of the Customised Scheme must be connected to a Data Centre.
4. **(With effect from 16 December 2022)** Services subscribed and spending by the customer and its related companies can be combined to meet the minimum quantities and spending required under the Customised Scheme.
5. **(With effect from 2 February 2024)** The customer shall subscribe to the minimum quantity as specified under Table B and Table C of the Customised Scheme.
6. The services offered under the Customised Scheme are subject to resource availability.
7. The customer shall not resell the services subscribed under the Customised Scheme.
8. Circuits subscribed under the Customised Scheme will continue at the customised prices after the expiry of the circuit contract term.
9. No other discounts including, but not limited to, term and volume discounts, shall be applicable to the services subscribed under the Customised Scheme.
10. All other standard prices, terms and conditions of the Singtel Gigawave service shall remain applicable.

Suspension and Termination Provisions:

In the event the customer terminates the service(s) subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for a premature termination charge of 100% of the remaining contract term.

Eligibility:

(With effect from 16 December 2022) The Customised Scheme is available to all similarly situated customers and their related companies who satisfy the following criteria:

- a. has a minimum revenue spend of \$10 million on Singtel services in the last 12 months prior to the start of the customer's agreement; and
- b. accepts the terms and conditions of the Customised Scheme in its entirety.
