- 4. One end of the Dark Fibre services subscribed under the Customised Scheme must be connected to a Data Centre.
- 5. The services subscribed under the Customised Scheme are subject to resource availability.
- 6. The customer will be charged the ARC as stated in the pricing table above from the first year onwards. For the avoidance of doubt, the ARC shall cease upon the expiry of the initial service contract term. Thereafter, services subscribed under the Customised Scheme will continue at a monthly recurring charge of \$5,000 after the expiry of the service contract term.
- 7. In the event that the customer requires a relocation of the Dark Fibre service(s) from the existing location to another location within mainland Singapore, the customer shall give Singtel at least 60 days' written notice. The applicable relocation charges shall be negotiated between the customer and Singtel.

- 8. The customer shall not resell the services subscribed under the Customised Scheme "as is" or as a standalone Dark Fibre service but may resell the service(s) as part of its own network services.

Suspension and Termination Provisions:
