4. **(With effect from 31 January 2024)** Circuits subscribed by the customer and its subsidiaries can be combined to meet the minimum quantities required under the Customised Scheme.
5. The customer shall not resell the services subscribed under the Customised Scheme.
6. The service(s) subscribed under the Customised Scheme are subject to resource availability.
7. Services subscribed under the Customised Scheme will continue at the customised prices after expiry of the service contract term.
8. The customer shall be eligible for external relocation waiver of two (2) Meg@POP IPVPN EthernetLink and/or Meg@POP IPVPN EthernetLink with Exchange Diversity circuits subscribed under the Customised Scheme.
9. No other discounts including, but not limited to, term and volume discounts, are applicable to the services subscribed under the Customised Scheme.
10. All other standard prices, terms and conditions of the Singtel Meg@POP and BizVoice services shall remain applicable.

### **Suspension and Termination Provisions:**

If the customer terminates the service(s) subscribed under the Customised Scheme during the contract term of the service(s), the customer is liable for a premature termination charge (PTC) of 100% of the remaining contract term.

**(With effect from 21 March 2024)** Notwithstanding the above, where the customer has subscribed to the minimum quantity of BizVoice services under the Customised Scheme, the customer is eligible for a PTC waiver for any additional BizVoice services (outside of the minimum quantity) subscribed under the Customised Scheme.
