**Key Terms and Conditions:**

1. **(With effect from 29 April 2024)** The contract term of the Customised Scheme is three (3) years with an option to extend for six (6) months, up to two (2) times.
2. **(With effect from 4 March 2024)** The contract term for the services subscribed under the Customised Scheme are as follows:
  - a. Table A: minimum of two (2) years; and
  - b. Table B: one (1) year.
3. **(With effect from 20 October 2023)** The customer shall subscribe to the minimum quantity of 40 Meg@POP IPVPN EthernetLink circuits under the Customised Scheme.
4. **(With effect from 20 October 2023)** Circuits subscribed by the customer and its subsidiaries can be combined to meet the minimum quantity and spending requirements.
5. Circuits subscribed under the Customised Scheme will continue at customised prices after the expiry of the circuit contract term.
6. The services offered under the Customised Scheme are subject to resource availability.
7. **(With effect from 20 October 2023)** The customer shall not resell the services under the Customised Scheme.
8. No other discounts including, but not limited to, term and volume discounts, shall be applicable to the services subscribed under the Customised Scheme.
9. All other standard prices, terms and conditions of the Singtel Meg@POP service shall remain applicable.

### **Suspension and Termination Provisions:**

If the customer terminates the services subscribed under the Customised Scheme before the end of the contract term, the customer will be liable for a premature termination charge (**PTC**) of 100% of the remaining contract term.

The customer is eligible for a waiver of PTC for circuits re-contracted under the Customised Scheme.
