5. The customer shall not resell the services subscribed under the Customised Scheme.
6. The services offered under the Customised Scheme are subject to resource availability.
7. Services subscribed under the Customised Scheme will continue at the customised prices after expiry of the circuit contract term.
8. No other discounts including, but not limited to, term, volume and discretionary discounts, shall apply.
9. All other standard prices, terms and conditions of the Singtel Meg@POP and Cloud Connect services shall apply.

Suspension and Termination Provisions:

If the customer terminates the service(s) subscribed under the Customised Scheme during the contract term of the service(s), the customer is liable for a premature termination charge (PTC) of 100% of the remaining contract term.

The customer is eligible for a waiver of PTC on any existing Meg@POP eLite services that are renewed under the Customised Scheme.
