- 1. The contract term of the Customised Scheme is five (5) years.
- 2. The contract term for the services subscribed under the Customised Scheme is as follows:
 - a. **Temporary services**: contract term is one (1) month, unless otherwise stated;
 - b. All other services: minimum contract term of one (1) year.
- 3. Services subscribed under the Customised Scheme will continue at customised prices after the expiry of the service contract term.
- 4. **(With effect from 21 July 2025)** The customer shall not resell the services subscribed under the Customised Scheme "as is" or as a full or sub-bandwidth standalone service but may use the services as part of its own network to offer its services.
- 5. The services offered under the Customised Scheme are subject to resource availability.
- 6. The customer shall be responsible for obtaining all authorisation(s) necessary for Singtel to access the customer's POP.
- 7. For Dark Fibre services, any request for relocation shall be deemed to be a request for the termination of the service(s) and a request for the supply of a new service(s) at the requested location, and the prevailing premature termination charges (**PTC**) shall apply.
- 8. **(With effect from 21 July 2025)** All other standard prices, terms and conditions of the Singtel Gigawave, Meg@POP, Dark Fibre and MetroEthernet services shall remain applicable.

Suspension and Termination Provisions:

In the event that the customer terminates the service(s) subscribed under the Customised Scheme prior to the end of the circuit contract term, the customer shall be liable for the prevailing PTC, except in situations where the termination of service arises due to the demolition of the building where the service(s) is housed in, the PTC will be waived under the above circumstance.

In order to enjoy the PTC waiver above, the customer must produce evidence from the building management to support the above circumstance. The customer may choose to relocate the affected service(s) to a new location subject to the OTC of the service(s). For the avoidance of doubt, such relocated service need not be renewed on a new contract term.
