4. The customer is eligible for the novation of services subscribed under the Customised Scheme to its related company. For the avoidance of doubt, the novated service(s) will continue on the remaining contract term, if any. Should the novated service(s) commence a new contract term instead, any applicable Premature Termination Charge (**PTC**) shall be waived as part of the novation.
5. The customer shall subscribe to the minimum quantity as stated in the pricing table above.
6. Services subscribed by the customer and its related companies can be combined to meet the minimum quantity required.
7. The service(s) subscribed under the Customised Scheme are subject to resource availability.
8. The customer shall not resell the service(s) subscribed under the Customised Scheme.
9. Circuits subscribed under the Customised Scheme will continue at the customised prices after expiry of the circuit contract term.
10. No other discounts including, but not limited to, term and volume discounts, are applicable to the service(s) subscribed under the Customised Scheme.
11. All other standard prices, terms and conditions of the Singtel Meg@POP service shall remain applicable.

Suspension and Termination Provisions:

If the customer terminates the service(s) subscribed under the Customised Scheme during the contract term of the service(s), the customer shall be liable for a PTC of 100% of the remaining contract term.
