Terms and Conditions:

- 1. The customer is required to maintain a minimum annual spend of \$8M on DigiNet and MetroEthernet services throughout the duration of the Customised Scheme contract term. For the avoidance of doubt, the total spend excludes spending on value added services.
- 2. In the event that the customer does not meet the revenue commitment above, the customer shall pay to SingTel, within thirty (30) days from the end of the relevant year, the difference between the actual spend and the minimum revenue commitment.
- 3. With the exception of the term discounts, no other discounts or promotions are applicable to the services subscribed under this Customised Scheme;
- 4. The services subscribed under the Customised Scheme are solely for the purpose of connecting to international gateway for international services, with one end connecting to the customer's POP.
- 5. The customer shall not resell the services "as is" or as a standalone DigiNet or MetroEthernet service but may bundle the services as part of its own network service.
- 6. No other discounts except those specified herein shall apply.
- 7. There shall be no auto-renewal for the Customised Scheme.
- 8. All other terms and conditions of the SingTel DigiNet and MetroEthernet services shall apply.

Suspension and Termination Provisions:

In the event that the customer terminates the service(s) subscribed under the Customised Scheme prior to the end of the circuit contract term, the customer shall be liable for a premature termination charge of 100% of the remaining contract value.

Eligibility:

The Customised Scheme will be offered to any customer who satisfies the following criteria:

- is a duly licensed Facilities Based Operator or Services Based Operator;
- currently has or is willing to commit to a minimum annual spend of \$8M on DigiNet and MetroEthernet services excluding value-added services; and
- accepts the terms and conditions of the Customised Scheme in its entirety.
