- 1.1. The minimum contract term for the services under the Customised Scheme are as follows:
 - a) Retail DigiNet Tail-End circuits: one (1) year
 - b) Retail DigiNet Head-End circuits: two (2) years
 - c) Retail MetroEthernet Point-to-Point: one (1) year
 - d) Resale Meg@POP: one (1) year
- 1.2. The minimum revenue commitments for the Customised Scheme are as follows:
 - a) not less than S\$4.9M per year for the services under the Customised Scheme in the first year;
 - b) not less than S\$5.7M per year for the services under the Customised Scheme in the second year;
 - c) not less than S\$7M per year for the services under the Customised Scheme in the third year;
 - d) not less than S\$7M per year for the services under the Customised Scheme in the fourth year; and
 - e) (With effect from 3 August 2010) not less than \$583,000 in the Extension Period.
- 1.3. In the event that the customer's spend per year is less than the revenue commitment for that year, the customer shall pay to SingTel the difference between the actual spend and the minimum revenue commitment for that year.

- 1.4. Should the customer choose to sign-up for a circuit under SingTel's prevailing promotional rate rather than the customised rates herein, the revenue from this circuit shall qualify for the minimum revenue commitment subject to the condition as stated above.
- 1.5. Point-to-MultiPoint MetroEthernet services with multiple head-ends (retail)
 - a) The prices above only apply to standard Point-to-MultiPoint MetroEthernet circuits. For the avoidance of doubt, circuits with diversity requirements are not eligible.
 - b) In order to align the contract terms of multiple head-end circuits, the existing head-end circuit(s) will be re-contracted with the addition of each subsequent head-end circuit.
 - c) The customer may only subscribe to the subsequent head-end if the existing head-end has 60 tail-end circuits connected to it and the existing head-end is at least 80% utilised.
 - d) All the head-ends must be installed at the same A-end.
 - e) In the event that the customer terminates a head-end circuit(s):
 - i) if there is only one head-end left then this remaining head-end will automatically be converted to the standard Point-to-MultiPoint MetroEthernet; or
 - ii) if there are multiple head-ends left and the total remaining bandwidth is listed in the Multiple Head-ends table then the price in the table shall apply otherwise, the head-ends will be converted to standard Point-to-MultiPoint MetroEthernet circuits.
- 1.6. All other standard terms and conditions of the SingTel DigiNet, MetroEthernet and Meg@POP services shall apply.

Suspension and Termination Provision:

Should the customer terminate a circuit within the contractual period, the customer shall be liable for premature termination charges of 100% of the remaining contract term on

DigiNet and MetroEthernet services, and 20% of the remaining contract term on Meg@POP services.

The premature termination charge shall not apply in the event that the customer, with SingTel's prior written consent, migrates a DigiNet circuit(s) to the retail MetroEthernet or resale Meg@POP services. Premature termination charges shall continue to apply for migrations from resale Meg@POP or retail MetroEthernet to retail DigiNet.

The premature termination charge for Point-to-MultiPoint MetroEthernet services with multiple head-ends (retail) are as follows:

- a) Regardless of the number of head-end circuits terminated, so long as there is one active head-end remaining, no premature termination charge will be applicable.
- b) If the customer eventually terminates the remaining active head-end circuit, the standard premature termination charge will apply based on the standard Point-to-MultiPoint MetroEthernet rates.
- c) If the customer terminates all the head-end circuits at once, the standard premature termination charge will apply based on the multiple head-ends rates.

Eligibility:

The Customised Scheme will be offered to any customer who:

- is duly licensed as an Internet Service Provider in Singapore;
- uses the services under the Customised Scheme for the sole purpose of providing Internet access to its end-users;
- installs the services under the Customised Scheme on its own network, at its own Internet exchange; and
- accepts the terms and conditions of the Customised Scheme in its entirety.
