21. A 50% discount off the prevailing list price shall be offered on standard and express (where applicable) one-time charges all the circuits in Tables 1 to 19.

22. A 20% discount off the prevailing list price, including monthly recurring charge & one-time charge, shall be offered on Bandwidth-on-Demand, disaster recovery, standby, temporary, Class of Service and Relocation one-time charge for WebNet,

MetroEthernet, GigawaveLite and Meg@POP services. For the avoidance of doubt, the prevailing service contract term applies.

23. The prevailing term discounts shall apply to WebNet, MetroEthernet, GigawaveLite and Meg@POP services.

24. Other than the discounts in paragraphs 20 – 22, no other discounts shall apply.

Key Terms and Conditions

1. The customer is required to maintain a minimum annual spend of \$29M on the services subscribed under the Customised Scheme for the duration of the Customised Scheme contract term.
2. In the event that the customer opts to subscribe to ISDN30, WebNet, MetroEthernet, GigawaveLite and/or Meg@POP services at the list or promotional price because the list or promotional price is lower than the customised price, this expenditure will be counted towards the revenue commitment.
3. In the event that the customer does not meet the revenue commitment for any given year, the customer shall pay SingTel the shortfall.
4. For the avoidance of doubt, one-time and premature termination charges may not be counted towards the revenue commitment.
5. There shall be no auto-renewal for the Customised Scheme.
6. The customer shall not resell the services subscribed under the Customised Scheme “as is” or as standalone WebNet, MetroEthernet, GigawaveLite and Meg@POP services but may use the services as part of its own network to offer its own services.
7. The prevailing terms and conditions of the SingTel ISDN30, WebNet, MetroEthernet, GigawaveLite and Meg@POP services shall apply.

Suspension and Termination Provisions:

1. In the event that the customer terminates a circuit subscribed under the Customised Scheme prior to the end of the contract term, the customer shall be liable for the prevailing premature termination charges.

2. The premature termination charge will be waived under the following scenarios:
 - a. waiver of premature termination charge and one-time installation charge for upgrade of domestic data services scheme; or
 - b. waiver of premature termination charge for early re-contract scheme.

Eligibility:

The Customised Scheme shall be offered to any customer who satisfies the following criteria:

- a) is duly licensed as an Internet Service Provider in Singapore;
- b) use the services subscribed under the Customised Scheme for the sole purpose of providing Internet access to its end-users;
- c) install the services under the Customised Scheme on its own network; and
- d) accept the terms and conditions of the Customised Scheme in its entirety.
