**Key Terms and Conditions:**

1. The contract term of the Customised Package is two (2) years.
2. The contract term of all circuits renewed, upgraded or subscribed under the Customised Package will be two (2) years.
3. The customised tariffs will be applicable to all renewed and upgraded circuits subscribed under the Customised Package.
4. If the customer wishes to take up new circuits as described above, the customised tariffs will also be applicable. In addition, the customer will also be provided a business DEL line and a router at no additional charge for each new circuit subscribed under the Customised Package.
5. The customer must complete the renewal/upgrade of its existing circuits within six (6) months from the time that the first circuit is renewed. If the customer is unable to complete the renewal/upgrade within 6 months, all services under the Customised Package will revert to the prevailing list price of the respective services.
6. The customer must complete the renewal/upgrade of its existing circuits before it can take up new circuits under the customised tariffs.
7. The customer shall not resell the Meg@POP services subscribed under the Customised Package "as is" or as a standalone Meg@POP circuit, but may bundle the service as part of its own network services.
8. There will be no auto renewal of the Customised Package.
9. The services under the Customised Package are subject to resource availability.
10. No other discounts or promotions shall be applicable to the services subscribed under the Customised Package.
11. All other standard terms and conditions of SingTel Meg@POP service, Meg@POP iLink service and Meg@POP BizLink service shall remain applicable.
