1. The minimum contract term for the Customised Scheme and the services subscribed under the Customised Scheme (**Services**) is one (1) year.

Terms and Conditions:

1. There shall be no auto-renewal for the Customised Scheme.
2. The customer is not allowed to resell the Services.
3. The Services are subject to resource availability. If any remote access facilities are required or for any customisation requirements, the customer will be quoted separately.
4. All other terms and conditions of the SingTel MetroEthernet service shall apply.

Volume commitment:

5. The customer is required to commit to the following:
 - a. migrate at least 400 x 2M DigiNet (i.e. either DigiLink, DigiPlus or both) circuits to 2M MetroEthernet Point-to-MultiPoint circuits within six (6) months from the date the agreement is signed;

- b. subscribe to and/or re-contract at least 13 x 10M, 8 x 20M, 1 x 30M, 1 x 40M, 8 x 50M, 2 x 100M and 1 x 1000M MetroEthernet Point-to-MultiPoint circuits in a single application within six (6) months from the date the agreement is signed; and
 - c. maintain a minimum combined tail-end bandwidth of 600M for the duration of the Customised Scheme contract term.
6. In the event that the customer fails to meet any of the above volume commitments, the monthly recurring charge for the 2M and 1000M circuits will revert to list price.

Revenue Commitment:

- 7. The customer is required to commit to a minimum annual spend of \$5M on SingTel services of which at least \$2.5M is on domestic data services. Domestic data services comprises For the avoidance of count, domestic data services comprise MetroEthernet, GigawaveLite, DigiNet, Meg@POP, ISDN, Analogue Leased Line and Videosonic services.
- 8. For the avoidance of doubt, spending on one-time and premature termination charges will be considered as part of the annual spend.
